The Street Project was discussed and tabled to next May's council meeting. Presently, the project is sitting at a high estimate of 9 million and a low of 6 million. Council would like that low estimate to come down much more, if possible. They would also like an estimate on patching only, to see if that is an option.

City Shop building insurance was discussed and a value of what is kept inside the shop is needed with an inventory list to updated yearly.

Utility billing for Right Direction Properties was discussed. It was moved by Aberle, seconded by Ferry to continue to bill as structured. Motion carried.

Auditorium updates were discussed. Laurie Tuite is working on a catalyst grant from the state with a possibility of a 50/50 match.

Appointment of new city council member was discussed. New member will be appointed until 2028.
